

Terms and Conditions – 2025 MS Moonlight Walk Final Week Fundraising Incentive Promotion

1. Entry into the 2025 MS Moonlight Walk **Final Week Fundraising Incentive** (“Promotion”) is deemed to be an acceptance of these Conditions of Entry. Information on how to enter the Promotion and prizes associated with the Promotion form part of these Conditions of Entry.
2. Entries for the Promotion commence on 00:01hrs AEST Monday 13 October 2025 and close at 11:59hrs AEST Sunday 19 October 2025 (“Promotion Period”).
3. Entry is open to MS Moonlight Walk participants (“Entrants”).
4. The Promoter reserves the right in their sole discretion to disqualify any individual who the Promoter have reason to believe breached any of these conditions, or engaged in any unlawful or otherwise improper misconduct calculated to jeopardise the fair and proper conduct of the competition. The Promoter’s legal rights to recover damages or other compensation from such an offender are reserved.
5. To enter, Entrants make or receive a donation to their fundraising page of more than \$10 during the promotion period.
6. Each valid entry received during the Promotion Period will be placed in the Prize Draw. There is no limit to the number of entries per participant. Each additional donation above \$10 qualifies as an entry.

11. Entries must be received by the Promoters within the Promotion Period. Entries are deemed to be received upon the verified total of the participants fundraising page increasing by any donation amount during the promotion period.

 - 12.1. The value of the prize pool is accurate at the date of commencement of the Promotion Period. The Promoter accepts no responsibility for any variation in the value of the Prize after that date.

- 12.4. The Promoter's decision is final, and no correspondence will be entered into, including in the event of a dispute.
- 12.5. If for any reason the prize is not claimed, the prize will be forfeited.
- 12.6. If a Prize Winner is under the age of 18 years (where entry by persons under 18 is permitted), the Promoter will award the prize to the Prize Winner's parent or guardian.
